AN ORDINANCE AMENDING SECTION 111.08 "ORDER OF BUSINESS" OF TITLE THREE
"LEGISLATIVE" OF PART ONE OF THE "ADMINISTRATIVE CODE" OF THE CODIFIED
ORDINANCES OF THE CITY OF SOUTH EUCLID, OHIO.

WHEREAS, the Council of the City of South Euclid desires to modify the Order of Business of City Council Meetings to provide increased communication and responsiveness to residents.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of South Euclid, Ohio:

Section 1: That Section 111.08 "Council Rules" of Title Three "Legislative" of Part One "Administrative Code" of the Codified Ordinances of the City of South Euclid, Ohio be hereby amended to read as follows:

111.08. ORDER OF BUSINESS

All meetings of Council shall be open to the public. Promptly at the hour set by law on the day of each regular meeting, the members of Council, Mayor, Clerk of Council and Director of Law shall take their regular stations in the Council Chambers and the business of Council shall be taken up for consideration and disposition in the following order:

- (a) Roll call.
- (b) Approval of minutes.
- (c) Report of Mayor.
- (d) Report of Law Director and departmental heads.
- (e) **Report of School District and Community Organizations**
- (e) Public hearings related to agenda items.
- (f) Report of committees.
- (g) Communications of City Council.
- (h) Public hearings related to open business.
- (i) Adjournment.

Section 2: That is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after November 25, 1975, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

A RESOLUTION

REGISTERING AN OBJECTION WITH THE OHIO DEPARTMENT OF COMMERCE DIVISION OF LIQUOR CONTROL CONCERNING THE RENEWAL OF THE LIQUOR PERMIT BELONGING TO THE INN CROWD LOUNGE IN THE CITY OF SOUTH EUCLID, OHIO.

WHEREAS, the City received a notice from the Ohio Department of Commerce Division of Liquor Control stating all permits to sell alcoholic beverages within the municipal boundaries will be expiring October 1, 2017 and are subject to renewal; and

WHEREAS, this notice stated that Ohio Revised Code Section 4303.271(B) provides City Council the right to object to the renewal of a permit and request a hearing prior to September 1, 2017; and

WHEREAS, all objections issued must be based upon the grounds set forth in Ohio Revised Code Section 4303.292(A); and

WHEREAS, the Law Director has determined substantial legal grounds exist within the confines of Ohio Revised Code Section 4303.292(A) to object to the renewal of the liquor permit belonging to The Inn Crowd Lounge, located at 4066 Mayfield Road; and

WHEREAS, the Police Chief has presented evidence to illustrate the validity of this objection.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of South Euclid, Ohio:

Section 1: That based upon the grounds set forth in Ohio Revised Code 4303.292(A), City Council wishes to register an objection with the Ohio Department of Commerce Division of Liquor Control concerning the renewal of the liquor permit belonging to The Inn Crowd Lounge, located at 4066 Mayfield Road in the City of South Euclid, for the following reasons: (1) the permit-holder operating the liquor permit business in a manner that demonstrates a disregard for the laws, regulations, or local ordinances of this state or any other state; and (2) the business is located in a manner with respect to the neighborhood that substantially interferes with public safety, decency, sobriety, peace, or good order.

Section 2: That the Council of the City of South Euclid respectfully requests the hearing concerning this objection be held in the City of Cleveland, Ohio as the County Seat of Cuyahoga County.

Section 3: That the Clerk of Council is hereby authorized and directed to certify a copy of this Resolution and transmit said copy along with a statement of support from the Law Director to the Ohio Department of Commerce Division of Liquor Control by September 1, 2017.

Section 4: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after November 25, 1975, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: That this Resolution is deemed to be an emergency measure necessary for the immediate preservation of the peace, health, safety and welfare of the residents and for the further reason Inn Crowd Lounge has proven to be a nuisance and must not be allowed to continue its current operations for the good of the community. Wherefore, this Resolution shall take effect and be in force from and after the earliest period allowed by law and upon signature of the Mayor.
