# **Report of Mayor**

- Mayor Welo reported that all directors are present at the meeting with Police Chief Nietert, Service Director Anderson and Engineer Blackley excused.
- Housing Manager Martin requested council consideration of the resolution to renew the agreement with One South Euclid to continue the CDC's working agreement with the city.
- Economic Development Director Love also requested council consideration of the One South Euclid agreement.
- Mayor Welo reported that she recently met with executives from Dollar Bank who have a 3-2-1 program to help prospective homeowners meet mortgage requirements. The Mayor reported on upcoming events including the South Euclid Garden Walk in June and reported on a program of the Cleveland Kosher Food Pantry in South Euclid that serves thousands of needy people. Ms. Welo reported that she attended the Saturday march in Downtown Cleveland to support our youth and families working for additional gun control measures and assault weapons ban. Mayor Welo discussed the agreement with One South Euclid, which is driven by residents of the city and the positive legacy they are leaving for the community.
- Mayor Welo thanked City Council for their diligence and passing the budget last week and stated that City Council has spent the last two years meeting on a monthly basis to discuss ways to reduce costs and increase revenues. Ms. Welo wished residents a happy Passover and Easter holiday.

- Councilwoman Goodman reported on the passing of community leader Beth Zone and a meeting that was held by the Jewish Elected Officials. Ms. Goodman wished everyone a happy Passover and Easter.
- Councilman Frank thanked the Fire Chief and firefighters for their recent CPR and First Aid Training that was offered to the community and stated that it was an amazing three hour course.
- Councilwoman Continenza wished residents a happy spring and asked for their consideration to not use pesticides and chemicals in their yards and to consider rain gardens to resolve drainage problems. Ms. Continenza reported on upcoming events including Arbor Day and the summer Bexley Concert Series.
- Councilman Gelfand wished residents a happy Passover and Easter and reported on the rally downtown for gun control on Saturday and that it is inspiring seeing what young people are doing. Mr. Gelfand reported on sponsorships needed for the South Euclid Lyndhurst Baseball and Softball Leagues and that the organization is great and gives students another opportunity to learn skills.
- Councilwoman Gray reported that there is an Ohio Ethics Training on April 23<sup>rd</sup> at 6622 Wilson Mills Road. Ms. Gray stated that she wanted to speak about something that's heavy on her heart and that she believes there are seven people on City Council because the exchange of different diversity of ideas brings different perspectives that others might not have, and that one perspective is not necessarily better than another member's opinion and not all Council members think alike and that is what diversity and inclusion is all about, respecting our right to be different and have a voice. Ms. Gray said she is concerned about an exchange that happened between Council President Fiorelli and herself and she does not want to be picked on and that being told to be quiet was demeaning. Ms. Gray asked for the same respect from Mr. Fiorelli that she gives him and that she will not settle for anything less.
- Council President Fiorelli asked all council members to complete their conflict of
  interest forms and reported on the upcoming County Health and Human
  Services Levy that will be on the ballot on May 8. Mr. Fiorelli thanked Director
  Benjamin for the great job on the latest issue of South Euclid Magazine and
  reported on the receipt of Annual Reports from the Police and Fire Departments.
- Councilwoman Gray reported that Issue 1 will be on the ballot in Ohio in May, which will try to reform the issue of gerrymandering and it's very important that we educate people about the issue.
