### **Report of Mayor**

- Mayor Welo reported that all directors are present with the exception of Police Chief Nietert and Fire Chief Stefko.
- Housing Director Martin reported that the house on Elmwood was demolished last week bringing closure to the neighborhood. Director Martin thanked everyone for their comments and congratulations on receiving an award from the Ohio CDC Association.
- Economic Development Director Love requested support of Resolution 54-18 for a Brownfield Phase One Assessment at 442 South Green Road and explained that a potential new property owner has an agreement to purchase the property and that if the purchase does move forward the new owner is willing to meet with neighboring residents to discuss potential tenants for the industrial building.
- City Engineer Blackley reported that 2018 road projects are nearly complete.
- Mayor Welo reported on several events she has attended including the 85<sup>th</sup> Anniversary of the Mayors and Managers Association, First Baptist Church's Faith Walk in Ward One, presenting to students at Brush High School and attending the First Suburbs Consortium meeting in Bedford Heights. Ms. Welo thanked Councilwoman Goodman for taking a group of 19 representatives from different countries in Cleveland as a part of a Council of World Affairs program on a tour of South Euclid's green and sustainable assets. Mayor Welo reported on upcoming community events including One South Euclid's Mingle at the Telling Mansion, October 25 Pumpkins in the Park, and the Community Partnership on Aging's 40<sup>th</sup> Anniversary fundraiser. Councilwoman Goodman stated that the City applied a fresh patch of blacktop on the section of Cedar Road that was causing disturbance and thanked the city.
- Council President Fiorelli stated that Fire Chief Doug Stefko arrived at the meeting.

Council President Fiorelli stated that the City must have public health services as mandated by the State of Ohio and that the County Board of Health provides those services for the City of South Euclid and almost all other communities in Cuyahoga County and even though the cost for services are rising at about \$15,000 a year for the next two years, the city does not have much choice.

Councilwoman Goodman stated that she has questions about the increases and would prefer that the legislation be placed on first reading and that someone from County Health present to Council at a committee meeting.

Councilwoman Gray explained that every city that utilizes County Health Department services is going to be paying the same proposed rate. Mayor Welo concurred, and stated that the legislation needs to be approved by end of year so there is time to have the County come to a meeting.

The motions were rescinded and the legislation was placed on first reading and referred to the Committee of the Whole.

Mr. Turner stated that this is the third time he has discussed this issue with members of city council and he has sent emails requesting an apology from both City Council and One South Euclid condemning Mr. Miller's actions. Mr. Turner stated that he has been attacked by the police and he wants to be treated right because he is a former cop, veteran and is a senior citizen and stated that if this is the way he is treated, what chance does a person like Councilman Russell have to be treated fairly.
