Public Hearings (Open Meeting) Related to Open Business

Jim Matejka, a resident of Broadview Heights stated that he has been a South Euclid Building Inspector for the last two years and is leaving the city to take a job closer to his home. Mr. Matejka stated that in his many years of experience in the field he has worked with many city departments and that the South Euclid Building and Housing Departments function very well and that permits are handled quickly and the staff are professionals and do a great job.

- Charles Turner, 4549 Lilac Road, spoke about the Mayor's newly revised rules and regulations for conduct at city hall which has just been posted and stated that he has been sited six times by the police for speaking his first amendment rights and that Mr. Cicero was the prosecutor for all of the court cases and that his rights have been violated and the Judge ruled against the city. Mr. Turner wished everyone a great Thanksgiving and said that he will be spending it in prison.
- Assistant Law Director Cicero responded to Mr. Turner's comments and stated
 that the Judge wrongly dismissed the court case and the city took the matter to
 the Court of Appeals. Mr. Cicero stated that the Mayor's rules are constitutional
 and he represents many other communities and no other community has issues
 regarding free speech and stated that cities can determine time, place and
 areas for protest and that Mr. Turner is free to protest all he wants on the
 sidewalk, but not blocking parking spots or driveways.

Communications of City Council

- Councilwoman Goodman discussed a tour she conducted with the municipal arborist association at Oakwood Commons and the Oakwood Green and also gave a presentation to the Alliance for Community Trees on the importance of the tree canopy.
- Councilman Frank stated that this Saturday is Small Business Saturday and emphasized the importance of shopping local year-round. Mr. Frank discussed fundraisers for residents in need and the Brush Baseball Fundraiser and wished everyone a happy Thanksgiving.
- Councilwoman Continenza scheduled a Utilities Committee Meeting for December 16 at 6 pm to discuss Resolution 61-19 and reported on a meeting with Rust Belt Riders with city staff regarding a potential composing program. Ms. Continenza discussed conversations with youth regarding recreation initiatives.
- Councilman Frank scheduled a Finance Committee Meeting for December 2nd at 7 pm regarding Rochling Glastic's request for financial incentives for their proposed expansion project.
- Councilman Tisdale thanked all of the residents that attended the South Euclid K9 Foundation's Pancake Breakfast and wished everyone a happy thanksgiving.
- Councilman Gelfand reported on a meeting he attended with Director Benjamin in Lakewood regarding the utilization of 100% Clean Energy which is resulted in the Resolution being placed on the agenda. Mr. Gelfand discussed upcoming Mercury Theatre Company productions and read a letter that he wrote to Senator Portman asking him to follow his conscience and do what is right for the country with regards to how President Trump is seemingly using the office of the presidency to pursue his own personal agenda to the detriment of the country and its interests. Mr. Gelfand asked that the letter be made a part of the record of the minutes of the meeting.
- Councilwoman Gray reported on the Ward One Meeting and thanked those
 that attended. Ms. Gray reported on an upcoming Housing and Tenants Seminar
 that she has organized with resident and attorney Tyessa Howard. The meeting is
 scheduled for December 4th at 7 pm at the community center. Councilwoman
 Gray discussed the importance of the upcoming 2020 Census and need to be
 aggressive in making sure that all residents participate and are counted. Mayor
 Welo concurred with Councilwoman Gray and stated that this issue is critical for
 the upcoming year.
- County Councilwoman Simon reported that County Council will be voting on a financial incentive to help keep Rochling Glastic in South Euclid and also discussed additional County programs including extending the tree grant program through County Planning Commission.
- Community Services Director and Clerk of Council Benjamin reminded City Council that earlier this year, City Council decided to hold only one Regular Council Meeting in December, which will be on the 16th.
- Council President Fiorelli thanked the residents for coming to the council meeting and attending the deer public hearing.
