#### Held via WebEx Virtual Platform

## **Report of Mayor**

- Mayor Welo gave an update on Ohio Senate Bill 310, which is Federal CARES Act dollars for local governments. The Bill has passed the Senate, but appears stuck in House Committee.
- Housing Manager Martin reported on the initial results of a community survey distributed via social media to help identify the impact of the Covid-19 pandemic on community residents.
- Community Services Director Benjamin discussed the Food Security Grant Program for residents, as well as plans for the youth summer food program.
- City Engineer Blackley gave an update on summer road projects, which are substantially complete and that bid documents are being prepared for Hinsdale Road.
- Mayor Welo thanked Service Director Anderson, Community Services Director Benjamin and Law Director Lograsso for the work they did securing the new solid waste and recycling contract as well as their work on the future road projects.
- Doc Janning, South Euclid's Poet Laureate recited the poem he wrote for Memorial Day celebration.

Law Director Lograsso stated that Doc Janning did a fantastic job with the poem.

#### **ORDINANCE**

An Ordinance establishing and regulating the Local Coronavirus Relief Fund #925; and declaring an emergency. First Reading.

Council President Frank stated that the legislation puts the city in the position to use the Federal CARES Act funds for Covid-19 related expenses pursuant to law.

Mayor Welo stated that there may be an additional piece of legislation necessary from the Ohio Auditor and if it is needed prior to the next regular council meeting, she would call a Special Meeting of Council.

Councilwoman Goodman stated that it says it can be used for COVID purposes and not likely general safety or security so how can it be used for police and fire. Law Director Lograsso and Mayor Welo responded that the Law Director is researching this and the last version of the bill does allow for it.

## Communications of City Council

- Councilman Gelfand: Announced that he is resigning from City Council and read the following letter of resignation for the record: "As my wife Sherry, our daughter Eden, and I are working increasingly from home, we have made the necessary but difficult decision to move to a larger house. It is necessary because we need more space. But it is difficult because in order to stay in my daughter's school district, we will have to move from a city we love, South Euclid, two miles away to Cleveland Heights. After I met Sherry fourteen years ago, we proceeded on our life's journey together. She moved into my Eastway Road home because of its quality, neighborhood, and excellent insulation with lower heating bills. Although we tried to sell her Cleveland Heights home back then, the Great Recession was brewing and we were unable to do so. We rented out her home for the last 13 years. Our current tenants plan to move out this summer and we will move in. I am deeply indebted to the people of South Euclid who have placed their trust in me three times as their Councilman at-Large in city elections, and to my colleagues on Council who chose me for leadership as President Pro Tern. It is a trust I have always appreciated and never take for granted. Please accept my resignation from Council, effective July 1, 2020. Between now and then, I will do everything I can toward a smooth transition and to continue working on Council to keep South Euclid a wonderful thriving city".
- Councilwoman Continenza stated that it has been a pleasure working with Councilman Gelfand and that he will be missed. Councilwoman Continenza scheduled a Recreation Committee for June 8 at 7 pm to discuss the deer population and summer recreation efforts.
- Councilwoman Goodman reported on the Local Government Clean Energy Caucus, a group of local elected officials led by her, Councilman Gelfand and Lakewood Councilman Tom Bullock. The Councilwoman gave an update on the tree canopy plan and that there is more work than the grant funds allowed.
- Councilwoman Gray commended the city for their excellent job in producing
  the Memorial Day Video and that it brought her to tears and that in times of
  trouble we give definition to who we are and what we stand for and South
  Euclid always rises to the occasion. Councilwoman Gray stated that she is sad to
  hear the Councilman Gelfand is leaving City Council and that his knowledge has
  been invaluable.
- Councilman Tisdale thanked Councilman Gelfand for all of his work and support and congratulated Brush graduates.
- Council President Frank stated that Councilman Gelfand will be missed and congratulated 2020 Brush High School graduates.
- Mayor Welo stated that Councilman Gelfand will be missed and that he has brought so much knowledge to the table as a legislator.
