## **Report of Mayor**

- Poet Laureate Doc Janning recited a poem in honor of Independence Day.
- Mayor Welo reported that all directors present except for Building Commissioner Heilman who is excused from the meeting.
- City Engineer Andy Blackley reported that the 2021 Road Program is substantially completed and the Oakmont Road project is well underway with a temporary water main being installed on the street. Mr. Blackley gave an update on the Mayfield Road and South Green Road projects.
- Mayor Welo stated that we are aware of issues on the side streets with cut through traffic as a result of the closing of Green Road and that the police are monitoring the situation.
- Economic Development Director Love gave an update on the Leopardo Project and reported that the roof and HVAC have been completed at the Service Department and HVAC has been completed at Community Center and the new flooring will be installed. Mr. Love stated that city hall improvements are continuing with the roof replacement underway and interior work continuing.
- Economic Development Director Love reported on Resolution 35-21 regarding a conditional use permit for an outdoor patio for 2 You Wines.
- Mayor Welo thanked Director Love for his hard work on this and other projects throughout the city.
- Mayor Welo congratulated Councilman Tisdale and Councilwoman Elston on a
  wonderful Juneteenth event and also congratulated Donna Zachary and Marge
  Koosed on a successful Garden Walk this past weekend. Mayor Welo reported
  that the first band concert of the season was held on Sunday featuring the Pop
  Tarts and that the concert series has been dedicated in the name of Ray Rhode
  who planned the concerts for so many years.
- Mayor Welo reported that beginning July 1st there will be no restrictions for use of the pools or registrations and thanked pool director Titus and community center director Martines for working hard on these efforts.
- Mayor Welo reported that Housing Director Martin concentrates on housing
  issues both regionally and nationally and that the Cleveland area has the third
  highest foreclosure ranking in the United States so we need to continue to work
  with city council to assist any residents at risk of losing their homes.
- Mayor Welo reported that the State Legislature have passed a new bill taking about 50% of the stimulus dollars allocated for South Euclid and other cities and giving it to the townships.

Mayor Welo stated that she supports the legislation adding a new patio for 2 You Wines and thanked owner Nakia Hudson for choosing South Euclid and making a commitment to the community. Mayor Welo congratulated Councilwoman Hardy for accepting a position on the board of the South Euclid Lyndhurst Historical Society and reported that the South Euclid Browns Barkers are planning a Sports Camp for youth and updated council on future events including National Night Out on August 3rd.
