Report of Mayor

- South Euclid Poet Laureate Doc Janning recited the evening's poem in commemoration of Thanksgiving.
- Mayor Welo asked for a moment of silence was observed for former City Councilman Stanley Stein who passed away recently at 92 year of age and served on City Council from 27 years until 1991.
- Mayor Welo reported that all directors in attendance
- Police Chief Joe Mays gave an update on the USDA's deer management program and reported that 90 deer have culled and that no more culling will take place this year, as the pilot sterilization project begins in December. Councilwoman Goodman asked if there is an update on the recent homicide of the elderly woman in Ward 4. Chief Mays responded that BCI is working on trace evidence collection and a reward for information is being offered by Crime Stoppers.
- City Engineer Blackley reported that the Oakmount Road Infrastructure Project is substantially completed, and the contractor will return in the spring to do seeding and mulching. Mr. Blackley stated that the County project on Green Road is now completely paved, and crews are working on the concrete pavement section between Urban Road and Anderson Road and expects completion by the end of the month.
- Community Services Director Benjamin reported on the upcoming Light Up Holiday Smiles lighting ceremony with First Energy that will take place on December 1st from 4 pm – 7 pm.
- Economic Development Director Love reported on the progress of the Leopardo project, and that City Hall construction should be completed this year, with Community Center improvements underway at the beginning of 2022.
- Mayor Welo thanked that staff for being flexible and working around the construction at City Hall and also thanked Finance Director Wendt for taking the time to train all directors on the new VIP budget software as the administration prepared to present the 2022 proposed budget.
- Mayor Welo reported on the opening of two new businesses that opened recently in South Euclid including Sprinkles and Milk and Jersey Mike's Subs at Cedar Center North and stated that shopping local is critical for the community.
- Mayor Welo reported that she has been on weekly calls regarding the pandemic and Covid-19 infections have been increasing and creating delays at local emergency rooms. The ER delays have resulted in several of our ambulances sitting at the hospital for several hours. Ms. Welo asked residents to consider getting vaccinated, getting the booster shot and consider wearing masks again.
- Mayor Welo congratulated Community Services Director Keith Benjamin for his work in winning the First Energy Light Up Holiday Smiles award for the City and that we beat out 16 other cities for the professionally designed holiday lighting display because of the City's efforts to promote diversity and inclusion.
- Mayor Welo wished residents a happy Thanksgiving and Happy Hanukkah to those who celebrate.

Report of Law Director. Law Director Lograsso reported on legislation on the agenda to approve the new fire union collective bargaining agreement and stated that the only change to the contract is the 2% cost of living pay increase for each of the three years.
