# Report of Mayor

- South Euclid Poet Laureate Doc Janning recited the evening's poem "Limitless".
- Council President Frank reported that Mayor Welo is unable to be at the meeting and reported that all directors were in attendance.
- Economic Development Director Mike Love gave an update on the Leopardo project and reported that the HVAC equipment was delivered for City Hall, the roof is currently being installed and flooring and painting in the Administrative offices were completed last week. Mr. Love stated that the elevator in the Police Department will be rebuilt in February and renovations to the community center will begin early next year. Mr. Love requested consideration of Resolution 61-21 renewing the agreement for OhioBiz webmaster services for 2022.
- Community Services Director Benjamin reported on the public hearing that was held on December 2<sup>nd</sup> to hear public comment on the city's request for Community Development Block Grant funding and requested consideration of Resolution 52-21 to apply for the grant.
- Police Chief Mays gave an update on the Deer Sterilization Project and reported that as of yesterday, 24 deer had been sterilized without any issues.
- City Engineer Blackley reported that the construction on South Green Road should be completed for the season and reopen this week. Mr. Blackley reported on planning for the phase II Oakmount Infrastructure project that will take place in 2022 and addressed Resolution 60-21 renewing his engineering services agreement with the city for 2022.
