- Councilman Fahsbender expressed his sadness of the untimely death of the boy that passed way from a tragic accident and sated that as a father he can't

imagine the pain the family is going through, and expressed his thoughts and prayers.

- Councilwoman Elston reported that next Tuesday is the Primary Election Day in Ohio and reminded residents to vote. Councilwoman Elston reported that she recently enrolled her nephew at Greenview School and expressed how wonderful the principals and counselors have been in helping navigate the new school environment.
- Councilman Frank acknowledged the members of the Police and Fire
 Department that were voted "Officers of the Year" and stated that we have
 great safety forces because of the community's r support of the Safety Levy, we
 wo officers of the year. Mr. Frank reported on Substitute HB 519 in the Ohio
 Legislature which is another attack on local government home rule and trying to
 mess with municipal finances.
- Councilwoman Continenza also responded to the tragic death of the boy, who
 was her neighbor and stated that she has started a fundraising page to help the
 family cover financial expenses. Ms. Continenza discusses the importance of gun
 safety and education about mental health issues. Ms. Continenza reported on
 the upcoming Farmers Market at Quarry Park and that she is beginning planning
 for the annual Bexley Bash to be held in conjunction with National Night Out on
 the first Tuesday in August.
- Council President Gray thanked Councilwoman Hardy and the PTA for nominating her for a Founders Day award and also reported on her participation the Fashion Show to benefit the Community Partnership on Aging. Ms. Gray reported on how wonderful it is to see ambassadors out cleaning the streets in the Mayfield and Green District and thanked Mayor Welo. Director Love stated that the effort is the result of the City's participation with the Downtown Cleveland Alliance pilot project.
